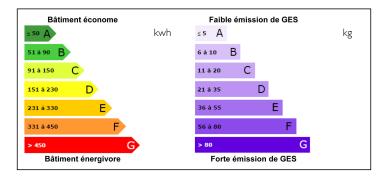

#### DESCRIPTION

From the very large car park, you climb 12 steps to a 50 m<sup>2</sup> terrace with pergola and a capacity of around 16 people. 5 more steps take you to the main entrance, but there is also a step-free access directly into the dining room. The main entrance leads into the bar (full IV licence + operating permit) with stools and a lounge with armchairs and television. The decoration is smart and well maintained with a light coloured tiled floor, exposed beams, wood and stone. The first dining room, equipped with a beautiful open fireplace offering incomparable charm to the room, can accommodate around 45 people. The second adjoining room can accommodate around 15 people.

Exceptional work tools are in place:

- a well-equipped kitchen with recent appliances and an exterior access door,

- a dessert preparation area independent to the kitchen,

- a large bar with coffee machine (under a rental/maintenance contract: the only contract attached to the business),
