




IN BRIEF

These two houses have been fully renovated to create two independent dwellings which could be used as a main residence with a gite, or as two rental properties. They sit around a courtyard, where there are numerous outbuildings which could be converted into additional accommodation, or used as stables On the ground floor of the main property are a large open plan living space, with kitchen, a shower room with WC, and a further room which could be an additional lounge, office, or ground floor bedroom. The first floor comprises three bedrooms, two of which have views over the land, and a bathroom. The second smaller property has an open plan kitchen and lounge area, and a separate WC on the ground floor, and two bedrooms and a bathroom on the first floor.

DESCRIPTION

Both properties are insulated, double glazed and heated with programmable electric heaters. There is also a log burner in the main house.

The properties sit around a courtyard with outbuildings attached. There is also a separate house for renovation.

Also suitable for horses, the properties sit on a plot of 15,095m2.

Located 10km from Lamballe and between the villages of Saint Aaron and Henensal. The beaches of Erguy and Pléneuf-Val-André are a 15-minute drive.
